PUERTO RICO TREASURY REPORTS GENERAL FUND NET REVENUES TOTALED \$713.8 MILLION IN MAY; \$66.9 MILLION ABOVE MAY 2015 AND \$30.8 MILLION BELOW ESTIMATES

FY 2016 YEAR-TO-DATE REVENUES WERE UP BY \$280.2 MILLION YEAR-OVER-YEAR AND \$14.9 ESTIMATES

Sales and Use Tax totaled \$201.2 million, \$82.7 million above May 2015

(San Juan, Puerto Rico) – Treasury Secretary Juan Zaragoza Gómez reported that net revenues recorded by the General Fund in May totaled \$713.8 million, \$66.9 million above net revenues in May 2015, and \$30.8 million below revised estimates.

The Sales and Use Tax (“SUT”) was the main revenue driver with \$201.2 million, a \$82.7 million year-over-year increase. The difference is attributed mainly to the increase in the state SUT rate to 10.5% from 6% and the 4% tax on designated business-to-business and professional services (known as B2B). SUT revenues were allocated as follows: \$191.3 million to the General Fund; \$9.6 million, or 0.5%, to the Municipal Administration Fund; and \$270,000 to the Film Industry Fund.

Corporate income taxes registered year-over-year decreases of \$19.9 million. In contrast, individual income taxes registered an increase of \$8.2 million, and the alcoholic beverages and motor vehicle excise tax categories increased by \$2.7 million and \$2.9 million, respectively. The Treasury Secretary pointed out that the increase in this last category coincides with motor vehicle industry reports of positive sales over the past two months.

Fiscal year-to-date net revenues totaled \$8.26 billion, a year-over-year increase of \$280.2 million, or 3.5%, \$14.9 million above revised estimates, and \$308.1 million below the original budget for FY 2016.
